


Strategies for Hill Visits

Know Your Member

- Research your <u>Congressional Members</u> biography, committee assignments & policy priorities.
- You may find that someone helped establish a National Historic Landmark, provided assistance with a local tax credit project, or sought funding for a specific preservation project. In some cases, you'll be talking to someone who has no track record with historic preservation at all - and that's OK!
- Share your knowledge of preservation, the district, and how your work relates to a given program.
- Focus on building a 2-way dialogue to share information & problem solve the issues at hand in a bipartisan manner. Offer to serve as a resource.
- Create an opportunity for more dialogue. Invite the member and/or staff to visit a historic site or HTC project in their district. If there's an upcoming event in the district, invite them to attend!

Be Prepared

- State coordinators should 1) prepare state & district specific one pagers; and 2) print copies of the official advocacy week one pagers to leave behind at each meeting.
- Talk with other advocates in your state ask questions and exchange ideas ahead of your meetings!
- Wear business attire and comfortable shoes.
- Bring business cards.
- At the conclusion of the meeting, ask for a picture.





HPF Appropriations

ASK: Support FY 2026 Historic Preservation Fund appropriations of \$225 million

- \$70 million for SHPOs
- \$34 million for THPOs
- \$121 million for preservation grant programs

TALK TO: Members of Congress & staff, especially members of the <u>House</u> & <u>Senate</u> Appropriations Committee, especially those on the Interior subcommittees.

- Appropriators: Thank/encourage their support of HPF; remind them that more funding is needed to carry out the essential programs funded by HPF.
- Non-Appropriators: Ask them to voice support of the HPF request to the Chairman & Ranking Member of the Interior Appropriations Subcommittee.

Historic Tax Credit

ASK: Support provisions in the emerging tax bill to make the federal Historic Tax Credit more valuable and easier to use by

- Returning the HTC to a one-year credit
- Eliminating the basis adjustment
- Expanding eligibility for the credit
- Enhancing the credit for smaller projects

TALK TO: Members of Congress & staff, specifically members of the <u>House Ways & Means Committee</u> and <u>Senate Finance Committee</u>.

Preserve Our Heritage, Invest in Our Future

ASK: Give consideration to federal actions that could negatively impact historic places

- Retain, hire & recruit qualified federal staff
- Ensure adequate capacity to support revitalization
- Support efficient review for important projects

ASK: Commit to the bipartisan enhancement of the Historic Preservation Fund by

- Reauthorize the program at \$250 million dollars annually for the longest interval possible
- Extend the current program authorization for 1 year, whilst the longer term solution is negotiated

TALK TO: Members of Congress & staff, especially members of the <u>House Natural Resources Committee</u> and <u>Senate Energy and Natural Resources Committee</u>, especially those on the Federal Lands & Public Lands subcommittees.



Historic Preservation Caucus

ASK: Join the U.S. House Historic Preservation Caucus (or thank if your member is on it)

TALK TO: Members of the U.S. House of Representatives (& their staff)
